MINUTES OF THE HELD OVER SPECIAL MEETING AND REGULAR MEETING OF THE CITY COUNCIL OF GLENDALE, COLORADO

Mayor Dunafon led attendees in the Pledge of Allegiance.

1. Call to Order and Roll Call. Mayor Dunafon resumed the special meeting of the Council. Veronica Marvin, City Clerk, called roll. The following Council Members were present: Rachel Binkley, Storm Gloor, Dario Katardzic, Lindsey Mintz, Ryan Tuchscherer, and Mayor Pro Tem Rigoni. City Attorney Matt Giacomini, City Manager, Linda Cassaday and members of City Staff also attended the meeting.
2. Resolution No. 8, Series of 2020, A Resolution of the City Council of the City of Glendale, Colorado, Supporting Governor Polis' Order To Wear Facial Coverings In Indoor Public Spaces And Taking Additional Steps To Implement The Order. Mayor Dunafon read the matter into the record by title only, all council members having received copies of the same. Deputy City Manager, Chuck Line, detailed the conditions of the Governor's Order and explained why the City of Glendale no longer needs to issue an ordinance on facial coverings. Mr. Line continued to explain why an opt-out of Tri County's Facial Coverings Order is required in order to align with the Governor's Order. Mayor Pro Tem Rigoni motioned to approve the Resolution. Council Member Mintz seconded the motion, and the motion passed unanimously.
3. Adjournment. The meeting adjourned at 7:49 p.m., after a motion by Mayor Pro Tem Rigoni


1. Approval of Agenda. Council Member Mintz moved to approve the agenda. This particular motion requires no second. There was unanimous consent of the Council.
